

Jordan is a specialized driving instructor, firearms instructor, and rapid deployment instructor for the agency and teaches security/active shooter presentations throughout the year.

Dr. Eric Davis

Dr. Eric Davis and his wife, Teresa, have been married since 1979 (over 44 years). They have two sons who are married, and the Davises are proud grandparents of 4 amazing grandsons. Following a 40+ year career in ministry, Dr. Davis now serves Cleveland County, NC as the Employee Support Manager and Emergency Services Chaplain. Dr. Davis is a Veteran and holds a Doctorate in Pastoral Care and Counseling from Gardner-Webb University. While attending Gardner-Webb, he received many academic accolades, including induction into Alpha Chi and Phi Chi, and attained the first Bruce Rabon Academic Achievement Award (for outstanding accomplishment as a doctoral student). While he worked as a full-time pastor in Cleveland County, he has served over 32 years as the Lead Chaplain for the City of Shelby Fire and Rescue Department. Since 2005, he has served as the Lead Chaplain for the Cleveland County Sheriff's Office and Cleveland County 911 Communications. Since 2014, he has correspondingly served as the Chaplain for Cleveland County Emergency Medical Services and Cleveland County Emergency Management. For well over 12 years, he has served as the Associational Chaplain for Volunteer Fire Departments of Cleveland County. He has received extensive training through the International Critical Incident Foundation (ICISF) and is certified as a Peer Support Team Leader, Crisis Intervention Counselor, and QPR (Suicide Prevention) Gatekeeper Training Instructor. In his present position, Dr. Davis is available to assist all Cleveland County Government employees by providing cognitive, emotional, relational, and spiritual support and counseling. He is very involved in teaching Tactical Resilience to emergency services personnel as well as Peer Support Management, Grief Care, and Suicide Prevention to various departments within county government.

Lieutenant Brendan Furguson

As a Paramedic Lieutenant with Cleveland County EMS, Lt. Ferguson leads emergency medical teams providing crucial care during critical situations. His expertise extends to the realm of law enforcement, where he serves as a Tactical Paramedic with the Cleveland County Sheriff's Office. 



We will be meeting at the shooting range at 2 PM. Please feel free to arrive early and bring your lunch. Picnic areas are provided. The range has us on their schedule on Thursday, April 11, 2024, from 2-4 PM.

Please note the following:

Everyone should watch the safety video and execute a waiver. This can be done online at https://foothillspublicshooting.cc/ or in the office. If done online, the waiver will be printed here at the office, not on your printer. Everyone who comes to the range must have a waiver, even if only spectating. If minor children are attending, the parent/legal guardian must execute a waiver for the minor.

Everyone must have eye and ear protection. If you wear prescription glasses, a hat or visor should be worn to offer additional protection for your eyes.

Everyone should bring their firearm. There are shotguns in the office for rent at \$5.00.


No steel core ammo is allowed on the range. If in doubt, take a magnet and touch the tip of the projectile. If it sticks, it cannot be shot at the range. No calibers larger than .338 Lapua or 50 BMG are allowed.


If shooting a Shotgun, nothing larger than 7 lead shot and nothing greater than 1300 fps. (7, 8 and 9 are accepted!)

Each attendee will pay for their own admission. Admission is \$12.00 per person, and there is a \$2.00 late fee. One free paper target is given with each lane fee purchased (\$14.95 with tax). If someone is shooting only a shotgun, admission is \$3.00 plus \$6.00 per round for skeet/trap and \$8.00 per round for 5-Stand. A round of skeet/Trap and/or 5-stand takes approximately 45 minutes to 1 hour to shoot.
